



Annual Report to the Parish Council 2020-21

### **Background and Strategic Overview**

Initiated in the pub over a beer in November 2019 at the suggestion of co-founder, David Brooks, the South Leigh Forest Restoration group (SLFR) has made good, but slower-than-hoped-for, progress in its first 18 months. We had aimed at planting 200 trees per year for five years and we have planted 100. Future planting towards the objective of 1,000 trees is uncertain. Private planting, however, has resulted in more than 1,700 trees being planted.

We believe that this initiative and its frequent communication and 'community involvement' has raised a very positive awareness of trees and sustainability in the Parish and contributes towards the general long-term Neighbourhood Plan objectives for South Leigh as a precious rural community.

The difficulty in sourcing sites is disappointing. That is partly because of the new government agriculture policy that was released early this year over which there is confusion among land owners / managers. This has resulted in landowners' understandable reluctance to allocate land to us from which they might, potentially, be able to benefit from grants, themselves.

That is not all bad because the thrust of the new government policy, as we understand it, is to remove certain crop subsidies and to replace them with grants to land owners for contributing to the environment and sustainability, including tree planting. We don't mind who plants them, or who pays, so long as they are planted. We still believe, however, that there is an important role for a small scale, inclusive community endeavour, such as SLFR.

We have learned a lot about trees, planting and local land ownership and the time it takes to raise funds since the first beer. We are now working hard to find one or two large sites so that we can 'catch up' with our SLFR objective of planting 200 trees a year towards the 1,000 by 2024/25. That remains elusive.

### **Where and what**

As at 30th April 2021, all the trees we have planted have taken well and are, by early May, in leaf with the oaks lagging behind, as we'd expect. Some are in early blossom.

### **Species**

The species that SLFR group has planted are all native, as per our plan i.e.: English Oak, Beech, Hornbeam, Silver Birch, Rowan, Field Maple and Wild Cherry, as recommended by Mike Kirk of Hadingham Kirk Gardens Ltd, and TOE (Trust for Oxfordshire Environment).

## Looking ahead

As reported in March, we have now exhausted all the sites for which we have permission to plant, although Eynsham Park Estate have said that they would consider plantings on the west side of Church End between Margery Cross and the Village Hall to replace the avenue of elms shown in old photographs.

We have already written to the estate managers asking if we may plant there and in the field behind the Village Hall and we continue to establish the ownership of a large site in Moor's Lane. This would answer all our problems as there is room for several hundred trees that we could plant over several years. Again, any help with advising us who owns the huge field at the junction of Moor's Lane with the old Railway line, would be much appreciated.

If we are unable to secure new sites, it may be necessary to change strategy somewhat. We have a plan for this that would result in creating a micro nature park of about an acre on land that we believe could become available. In the meantime, we shall continue to focus on our original objective under our existing strategy, which is:

**Simple, Focussed, Visible, Inclusive, and at no or minimal cost to the Parish Council.**

## Conclusion

We are reasonably satisfied with progress to date and will strive to find additional sites. We thank the outgoing Parish Council for its support and we trust that the new Council will wish us to continue.
